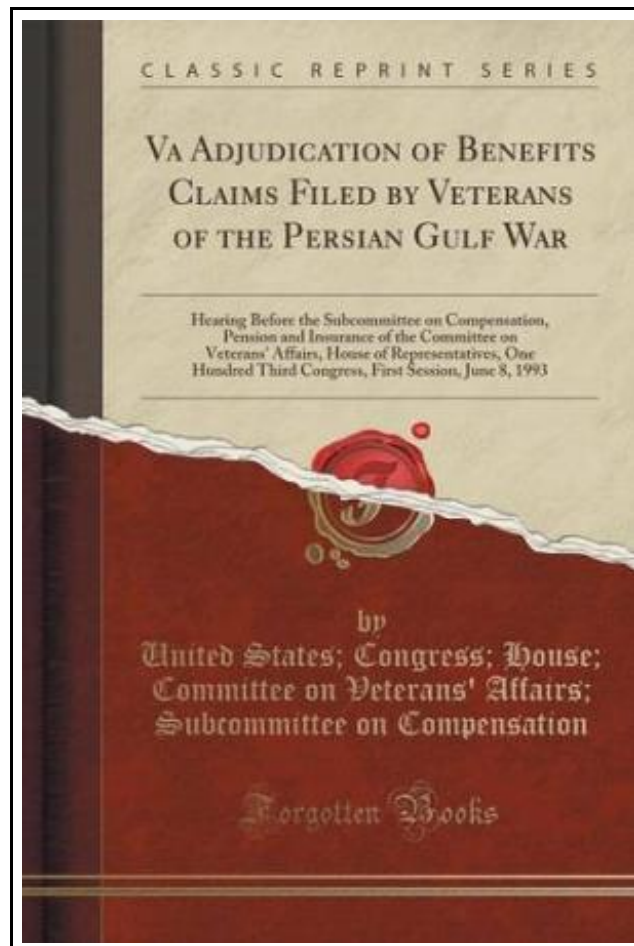

We also wish to learn more about the problems these veterans may be facing in establishing the validity of their claims. Finally, we want to be advised of actions the VA and the DOD are taking to insure that these veterans receive every benefit to which they may be entitled on a timely basis. I want to assure all Persian Gulf War veterans that we will continue our oversight on this issue and that we will continue to push for a thorough examination into the causes of the disabilities from which these men and women are suffering and to look for solutions to the...
